Lectures “Highlight” :Both nurse negligence and nursing staff being sued for nursing malpractice fall into the classification of TORT LAW: Gross negligence of doctor :Adomako’s case (end up in jail – why?) / Nurse acts under the instructions of a doctor / Professional judgment of RNs / Obviously incorrect and dangerous dosage ordered by doctors / Sponge in Abdomen after OT – OT Nurses liability / Nursing staff being sued for “left the situation at that” ! / OCCUPATIONAL SAFETY AND HEALTH ORDINANCE (職業安全及健康條例) - Chapter 509 / Pediatric nurses – was sued for misdiagnosis – “Child Abuse and nursing malpractice case” / ERE Nurse sued for “Too many sticks” applied to ER patient / Psychiatric Nurse - Subrogation action Vs Vicarious Liability / Malpractice Insurance Policy / Nurses Volunteering Nursing Care / Midwife Council : Code of Professional Conduct – obligation to act under emergency (?) / Does not turn-up for Follow Up or further ATT injection - RN’s negligence (?) / Hospital By Law - Take photos or video pictures of nursing staff and patients.
